The Clarke County Board of Supervisors met in regular session on March 9, 2020, at the Clarke County Courthouse with the following members present: Dean Robins, Marvin McCann and Larry Keller. Also present, Auditor Janice White, Ed Stoll and Recorder Peggy Cummings. Chairman Dean Robins called the meeting to order at 9:00 a.m. Marvin McCann made a motion to approve the agenda, seconded by Larry Keller. All Ayes.

**Res 19-044** – Moved by Marvin McCann, seconded by Larry Keller, to approve and sign new Shred-it Service Agreement for the Clarke County Office of Department of Human Services.
